If you are an international applicant, you are required to certify that you have sufficient funds to cover your expenses while attending OTS. In computing your expenses, you should bear in mind that students holding Student (F) visa will NOT be authorized to work except under extraordinary circumstances. Therefore, the applicant should not consider employment, either part-time during the academic year or full-time during the summer, as a significant means of support while at OTS. Under NO circumstances are students permitted to work full-time during the academic year. Spouses of F-1 student visa holders (i.e., F-2) are NOT permitted to work under any circumstances.
